It is because of strong quest for dominance, rich, famous, that majority of youths are undergoing trials in the law court, some have started serving jail terms, and some are facing trials in the court, while some have met their untimely deaths. It is very saddening that vast majority of youths that indulge into these obnoxious practices are formerly converted Christians.

It is of no doubt that the anger of God is on youths that practice those evil that were put off by men of God. This is why many youths have cried because, they do not know how it will end on them (Nwadialor & Nwokeocha 2023). Resurgence of idolatry practices are existential threats to Nigeria because it has been a scourge and could land many homes where those youths comes from to sudden destruction if necessary care are not taken. High browed men of God who stood as God's witnesses' from England, Portugal, island and Rome visited Nigeria and discovered that the condition of Nigerians toward practice of idols would make

Nigerians wallow into extinction. On that note, bad conditions of Nigerian were rescued and their idols rendered powerless. Some idols that kills human beings frequently were strangled by heavily power and the state of Nigerians land then were filled with Holy Spirit. It is badly revealing today that, many youths have turned themselves to Ezewanwoke, Ezewanyi. Many rivers and four crossed roads in Nigeria have become a place where most Nigerian youths do sacrifices to wake water spirits. Entrances of many rivers and turbulent flowing waters in Nigeria are coloured with white and red cloths. Earthen pots, plastic plates, woods wrapped together, fowls and goats were killed to wake gods and goddesses into action. It was told from time of old. It is still believed today that the riches obtained from the hands of the gods may be attractive at the beginning but the person that is involved into this money making mays not go scot free. He or she must be tormented by the gods thereafter. However, many parents whom their children have indulged into the wake of those gods have heard how the richies of their children began and refused to disclaim those bad richness. The aftermath of the whole scenario have turned to sudden deaths to parents of those children. Carful watch of some families reveals many deaths of parents whom their ages are between 50 to 70 years. Many religious organizations have seen how many youths have gave backlash to education, career learning and trading. The back push to education and poor engagement of youths to different handicrafts angered the one of the renowned Anglican diocese in Awka to lament how millions of youths have been converted to idolatry practice as medium for fast money making.

Because of these inferno, thehead of the Anglican prelate in Awka Diocese have organized many conferences, symposiums for the sake of Nigerian youths that are frequently lured to worship of fetish idols. The recent synod conducted in Awka Diocese in which the present governor of Anambra state government was in attendance has helped to redress the high rush to idolatry practices in Anambra state. However, Anambra state is the first state to kick against these obnoxious practices Synod report of Awka Diocese (2022 / 2023). It is observed that

Reckless Abandon of Handicrafts skills and Education and Worship of Idols among Nigerian Youths

Many families that are poor have not refused to accept the so called wealth of this kind because, their sons and daughters are deeply involved in this fetish and syncretic ideologies. This ideology is permeating in the lives of the youths on daily basis and it has continued to raise many dusts on the future of many youths in the developing countries of the world where education and Christianity were subordinated and idolatrous practices pursued with vigor. In this era, up surge on idolatry practices is on the high side (Chukwudebelu, (2021). The upsurge of idols worship in different geopolitical zones of Nigerian have compressed and suppressed Christian worshippers. On daily basis, some young youths

have routinely converged in different shrines of the gods and goddesses seeking for quick money, powers to subdue and become giants or wealthy in their businesses.

Worship of idols have ruined the lives of majority of youths,. Majority of youths have suffered depression due to long awaited time to be rich, why many that refused to provide the resources demanded by the gods have continued to suffer for mental illness and inordinate lifestyles Eleweke (2023), the increase in high pursuit of material things of this life as observed in the lives of some youths have accelerated gangsters, cultism, dubiousness and kidnapping.

To who much is given, much is expected. It behooves on the government, religious organizations, address these unexpected to behaviours before it rears great entropies to Nigerian society. Parents should continue to give their children advises that will aid a good youthful living. Churches in Africa, especially the Roman Catholic Church should speak against these inferno. Civil society organizations had as well, kicked against this back drops (Nnatuanya 2023& Okoro 2018).

Statement of the Problem
